Thank you for requesting the comments of the Division for Historic Preservation of the Office of Parks, Recreation and Historic Preservation (OPRHP). We have reviewed the materials submitted in accordance with the New York State Historic Preservation Act of 1980 (section 14.09 of the New York Parks, Recreation and Historic Preservation Law). These comments are those of the Division for Historic Preservation and relate only to Historic/Cultural resources. They do not include potential environmental impacts to New York State Parkland that may be involved in or near your project.

We note that 19 Welling Place, Warwick, NY is not eligible for listing in the State and National Registers of Historic Places. We have reviewed the project description, existing conditions photos, and preliminary site plans submitted to our office on November 11, 2024. In order to continue our review, please provide the following additional materials:
