The Reorganizational Meeting of the Board of Trustees of the Village of Warwick was held on Monday, April 5, 2021 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY via Zoom Videoconference. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, William Lindberg, Corey Bachman, and George McManus. Also, present was Village Clerk, Raina Abramson and Village Justice, Jeanine Garritano-Wadeson. Others present: Charles Alonge and Elizabeth Knight. The Mayor called the meeting to order and led in the Pledge of Allegiance. The Village Clerk held the roll call.

#### **Presentation**

1. Charles Alonge, Rolling Thunder, NY Chapter 3 – Request that South Lynn Street be dedicated to CWO2 Danny G. Prial.

Mr. Alonge introduced himself and explained that he is a member of Rolling Thunder, NY Chapter 3, a POW and MIA organization. Mr. Alonge stated that ten years ago he started a street memorial program for his friend who was killed in Vietnam. Mr. Alonge presented the request to dedicate South Lynn Street, in the Village of Warwick, to fallen soldier CWO2 Danny G. Prial. Mr. Alonge explained that Rolling Thunder will supply the sign to the Village at no cost and that it would not change the 911 address. Mr. Alonge said the sign is DOT approved and can be placed on top of the existing street sign or it can be put on another pole.

Mayor Newhard stated that the request is also a motion on the agenda and inquired about the timeframe.

Mr. Alonge felt that the sign would be ready by the next Village Board meeting.

Mayor Newhard felt that it was a wonderful tribute to Danny and thanked Mr. Alonge for taking the time and for reaching out to the family. Mayor Newhard also stated that the Village is honored that Mr. Alonge thought of Danny and thought of the Town and that the family would be a recipient of this honor.

Trustee Cheney thanked Mr. Alonge for bringing this to the Village's attention and stated that it was much appreciated.

2. Elizabeth Knight - Do-It-Yourself Too Good to Toss.

Ms. Knight stated the continued public interest of the Too Good to Toss event. She explained how the event might continue safely this year through a campaign to encourage Warwick residents to host their own Too Good to Toss Mini by choosing a day or days in the month of June to put out their items that are too good to toss, with details listed on the Wickham Works and Sustainable Warwick website. Ms. Knight hoped that the Village of Warwick would organize a bulk trash pickup after this event as part of a collective effort to keep items out of the landfill. She explained that they would like to make yard signs available for pickup at an event ahead of the Too Good to Toss and that the signs would have the Too Good to Toss logo and a space for the homeowners to wright in the date of the week that they plan to participate. There will no charge for the participants for the sign, because Wickham Works hoped to do that with their advertising budget with some support from the Village because this year the event won't be taking place on the basketball court in the park and they won't be asking the Village or the Town to split the cost of renting tables, tents, chairs, etc. Wickham Works will provide guidelines of how to participate in writing and in any other presentations, suggesting that people maintain and adhere to current CDC health guidelines for all participants, including a list of acceptable and unacceptable items. Ms. Knight stated that they will make it clear that

disposing of the homeowners' items have to be in accordance with the Town and the Village, their trash service, the homeowner's association or any other rules or regulations they would be subject to from the Town and the Village or where they live. Wickham Works will suggest that people set up on Saturdays and Sundays only to be part of an official Too Good to Toss, rather than just a garage sale and will also suggest that they do not leave items on the side of the road, overnight, or during the week out of respect for the Town, Village, and neighbors and to avoid repercussions of violating rules and regulations of the forementioned organizations, municipalities, etc. Participants will also have to agree that their activity in the Too Good to Toss mini, held on their own property is their responsibility and they have to be able to work this out with their own homeowners' insurance and that Too Good to Toss, Wickham Works, the Town and Village of Warwick will not be held liable for any activity taking place on private property. Participants would be asked not to accept payment for any items advertised as Too Good to Toss and they will be encouraged to put up a Too Good to Toss sign a week in advanced and share information about their participation on social media and in their own circle of contacts. Ms. Knight explained that this would be a mini event held on residents own property to avoid useful goods ending up kicked to the curb and in the hands of people who need and want them. Due to COVID-19, Ms. Knight felt it would be irresponsible to hold an event at which hundreds of people would gather. In 2019, Ms. Knight said that an hour and a half before they opened, there were well over a hundred people waiting in line shoulder to shoulder and by 2:00 p.m. there were at least four hundred participants, with over a hundred volunteers. Ms. Knight felt that the Too Good to Toss Mini would be a great way to accommodate the community in a responsible way. Trustee Lindberg inquired if there would be a list of people that would participate in the event or if people would just drive around. Ms. Knight said that if it's important to the Village, they will put together a list of participating homes, make people preregister and put it on a website. Ms. Knight also felt that spreading the event out over a month, instead of two days, will reduce traffic jams and too many people in one place at one time.

Mayor Newhard confirmed with Ms. Knight that Wickham Works would give each participant a sign to say that it is part of the Too Good to Toss activity. Mayor Newhard also stated that a list would help people know where to go instead of driving around randomly.

Ms. Knight stated that the event would be proposed for June, well ahead of the Village bulk trash pickup due to the demand of the public.

Trustee Cheney thanked Ms. Knight and the Too Good to Toss organizers for thinking outside the box to come up with a workable way to effectively have an event that accomplishes the goals of a normal Too Good to Toss. Trustee Cheney suggested to maybe limit to event, instead of the whole month of June, to two separate weekends from

the standpoint of the people who want to find some of the gems that are out there, to not have to go about that process four times and maybe only have to do it twice. Ms. Knight stated that that was the original idea but thought it might cause too much traffic in the village if it was condensed.

Mayor Newhard agreed with Trustee Cheney that a shorter window was better and wouldn't cause traffic jams. Mayor Newhard and Trustee Cheney both felt it should be village wide for two weekends instead of being intense in one designated area.

Ms. Knight discussed the possibility of then hold the event closer to the Village bulk pickup. Trustee Cheney stated that bulk pickup is probably going to occur in September, and many people take vacations in July and August; therefore, early June may be the best situation because later in June there is graduation.

Ms. Knight reiterated that the event should then take place in early June, two weekends in a row regardless of what part of the Village you live in.

Mayor Newhard asked Ms. Knight to please stay in communication with the Village and with DPW Supervisor Mike Moser to orchestrate the event.

Ms. Knight formally requested that in leu of paying for the tents, tables, and chairs that the Village could pay for a banner and yard sale signs and that she would provide estimates for those costs. Mayor Newhard stated that the Village will help.

Ms. Knight thanked the Village for supporting their ability to continue the community service.

#### **Correspondence**

1. Letter from Leyland Alliance Communities, LLC requesting a change to Village zoning for senior housing development.

Mayor Newhard stated that the letter came to the Village a couple of years ago but Mr. Marquet is now requesting to talk to the Village Board again so he will make a presentation at the next Village Board meeting.

 Orange County Department of Planning – County Reply to Local Law to amend the Zoning Map to change the designation of 15 Elm Street (SBL 210-7-3) from Light Industrial to Central Business. Mayor Newhard stated that according to the letter, Orange County Department of Planning felt that there would be no effect on properties or the zone.

3. Letter from Attorney, Jay Myrow dated March 22, 2021 regarding the Village View Estates, LLC Subdivision Petition for Annexation and Application for Special Use Permit.

Mayor Newhard stated that in the letter, Mr. Myrow describes that the developer will be willing to put a easement on properties in the Town.

#### **Discussion**

1. Conflicting events - use of Railroad Avenue.

Mayor Newhard stated that the Village is receiving a lot of requests to use the parks which may create an issue with outdoor dining, for example Railroad Avenue and Railroad Green becoming close quarters if there will be bands and/or music or some sort. Mayor Newhard stated that the Village has to look at each application as it comes before the Board because the Village does have other venues such as Stanley-Deming Park which has electricity, a gazebo, more space, a bathroom and is a wonderful facility that some people don't think about using and some cases the Village hopes to direct events over there if it makes more sense for them. Mayor Newhard stated that he doesn't think the Juneteenth event will conflict with outdoor dining because it's early in the day and outdoor dining would begin afterwards.

Trustee Lindberg felt that Mayor Newhard was correct about the Juneteenth event on Railroad Green because the use of the park is from 9 a.m. -5 p.m., but the event starts at about 11 a.m., so if needed in this situation or other situations, the Village Board can modify the times, so it doesn't conflict with the dinner hour on Railroad Avenue. Trustee Lindberg felt that the Village will have to be more sensitive to the event hours.

2. Peddler's Permit – Astral Power.

Mayor Newhard stated that Astral Power is a solar company, and that the Village is actually part of their campaign. Mayor Newhard said that one of the early changes as a result of COVID-19 was to not allow door to door solicitation, because the Village felt it was the wrong message, but as things are changing quickly and dramatically, he felt it was worth revisiting peddler permits. Mayor Newhard felt that the COVID protocols that Astral Power adheres to is pretty stringent and that it makes sense. Mayor Newhard stated that he felt that peddlers' permits should be reviewed by the Board on a case-by-case basis.

Trustee Cheney asked if the Village received any interpretation from the Village Attorney relative to what constitutes the requirement for peddling and soliciting licenses because he felt that this request doesn't fall under the peddler definition that is in the Village Code and that maybe the Board needs to look at it and update it, but it looks like it's specific about the merchandise sold. Trustee Cheney felt that the Village Code doesn't seem to touch on someone going around and talking to a homeowner about another service that doesn't fit into the strict definition that's currently in the Code.

Mayor Newhard asked the Village Clerk, since the Clerk's Office receives the requests, if the Village gets many requests that fit into what Trustee Cheney described in the Village Code.

Village Clerk, Raina Abramson stated that the Village used to have a food delivery service that would request a permit but felt that solar sales fell under merchandise since the Village receives at least one to two requests per year from solar companies who want to go door to door to sell their services and products.

Trustee Cheney didn't have a problem with the Clerk's interpretation but thought that the Code could be strengthened to support the good practices that the Clerk's Office is using.

Mayor Newhard agreed that the Code needs to be looked at to be updated.

Trustee Cheney stated that the Code seems to go back to the 1950s when the vegetable man came around with a wagon and sold provisions and goods from that vehicle. Trustee Cheney said that in the past the hot dog carts and ice cream truck that were providing the drive around the village services were the ones that were getting the licenses.

Village Clerk, Raina Abramson stated that routinely the Village has once or twice a year solar companies requesting peddler permits and that they are the most popular.

Trustee Cheney stated that if the solar companies come to the Village requesting to solicit then the obvious response should be to provide the Village with the information and fill out the application and then the Village would issue the license.

Village Clerk, Raina Abramson stated that upon application process, those requesting a permit are then background checked through the police department.

Trustee Cheney said that he didn't know if there was anything that could be done if someone went door to door soliciting without the license if it didn't fit specifically into the definition, that the Village may not be able to necessarily do anything about that.

Mayor Newhard stated that when a company comes into town and starts soliciting without a license, the Village receives phone calls immediately.

Trustee Cheney agreed, but felt that he wasn't sure if the Village has the teeth in the current law to stop them if they fall outside of the definition so it should be corrected.

Mayor Newhard agreed and asked the Board if they feel comfortable moving forward with Astral Powers Peddler's Permit application.

Trustee McManus asked if they just do roof top solar or solar farms or both. Mayor Newhard felt that it was more like community solar.

Trustee Lindberg didn't feel that it was a problem but felt it would be helpful if the Village could advertise to the public that someone may be coming door to door. Trustee Cheney agreed since it is something that the Village of Warwick is supporting as a benefit to the community.

Mayor Newhard stated that they are also allowed in the town.

Funds are appropriated in budget code G8120-4400 in the 2020-21 budget.

#### **Discussion:**

Trustee McManus asked what kind of accident caused the damage. Trustee Cheney replied that it wasn't an accident, but that they get out of line and then the shaft ends up with a groove in it and the groove has to be either filled with some sort of a material and then the bearing has to be replaced, so the bearing basically failed and created the problem with the shaft and so this is replacing that bearing because they just wear out over time.

Trustee Lindberg asked if it was a specialized project since the quotes were far apart. Trustee Cheney stated that there are two ways to repair the shaft, one is to repair it with a material called Belzona which is a metal/plastic type mixture to fill the grooves and to reshape the shaft. The other companies don't use Belzona. They weld metal into the shaft groove and then retool the shaft by shaving the metal, which makes it more expensive. Trustee Cheney stated that the third

group, the highest bid, is a company out of Maine who are specialized in this and do it really well but are very expensive and more expensive than the Village needs to be at this point in time since the Village is going to be replacing the RBC units once the upgrade to the plant is done. Trustee Lindberg asked if they fixed the issue the last time. Trustee Cheney said that they did do work on a slightly different situation on an extensive problem with one of the RBC units and that they do great work, but felt that in this instance its best to use the belzona because the last time the Village had this situation it held up well, so felt that it was something that the Village doesn't need to spend extra money on, especially because they are going to be replaced with a different technology.
