# BOARD OF TRUSTEES VILLAGE OF WARWICK AUGUST 6, 2018

The regular bi-monthly meeting of the Board of Trustees of the Village of Warwick was held on Monday, August 6, 2018 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present were: Deputy Mayor, Barry Cheney, Trustees: Barry Cheney, William Lindberg, Eileen Patterson and George McManus. Mayor, Michael J. Newhard was absent. Also present were: Village Clerk, Raina Abramson and DPW Supervisor, Michael Moser. Others present: Katie Bisaro

Deputy Mayor Cheney called the meeting to order and led in the Pledge of Allegiance. The Clerk held the roll call.

Deputy Mayor Cheney: I'd like to start out by saying that Mayor is in Sullivan County this evening for the Sullivan Renaissance Awards Ceremony where he's going to be presenting the grand \$250,000 award. ## WASTEWATER TREATMENT PLANT IMPROVEMENTS PROJECT

## INTENT TO DECLARE LEAD AGENCY UNDER SEQRA

**WHEREAS** the Village of Warwick, Orange County, New York (hereinafter the "Village") has established the public benefit to the Village residents of the upgrade construction of an existing Wastewater Treatment Plant in the Village (hereinafter the "WWTP"); and

**WHEREAS** the proposed WWTP project is needed to ensure the public safety and protect surface waters and the environment; and

**WHEREAS** the Village has conducted various studies of the condition of the system and the means for improvements; and

WHEREAS the action of designing and constructing a new WWTP is a Unlisted Action under the State Environmental Quality Review Act (SEQRA) and must be treated as an Unlisted Action due to requirements of the NYS Clean Water State Revolving Loan Fund; and

**WHEREAS** Part I of the Long Environmental Assessment Form (hereinafter "EAF") has been completed by the Village Engineering Consultant, Barton & Loguidice,

**NOW, THEREFORE, BE IT RESOLVED** that the Warwick Village Board proposes to act as Lead Agency in the coordinated review of the Village of Warwick WWTP Project and shall distribute the attached Notice of Intent, Part I of the EAF, and project description and map to all potentially involved and interested agencies.

#### **DPW Supervisor's Report**

West reconstruction is completed. The road was reclaimed and paved with binder and top course. Crosswalks, parking spots were painted by our guys. Double yellow lines were done by a contractor. Thank you to all effected for your patience. An excellent job was done by our crew. More paving upcoming. We need to do some infrastructure work on the roads that we are going to pave, so that's just going to be later in the season. We installed the Lion's water fountain at Stanley-Deming Park and I see that it appears to be getting a lot of use. We repaired catch basin's in Valley View, Laura Lane and Forester Avenue. Repaired a sewer lateral and installed a clean out on Third Street. We closed some roads and cleaned up some trees and debris from the wicked rain events that we've had. One was a hurricane type of event that happened during road

milling. We continue to fill potholes and ditches throughout the Village. We installed viewing stands at the library for an art walk. All 811 Dig Safe mark out requests were completed. All parking meters that had workorder complaints were repaired or replaced and meter money was collected. The men continue training on the new Ravo sweeper, training at their facility, and a mechanic was doing the first hundred-hour service at our shop today with Bob. A sign was installed at Stanley-Deming Park for the Playground of Dreams. Crosswalks, fire zones, loading zones are being painted throughout the Village. Mowing of all Village owned properties continues. We did some stump grinding and fixed the sidewalk at three different places on Oakland and Oakland Court. And the new walking path is being constructed from McFarland parking lot to the library. We started it the other day and we should be completed by September.

Deputy Mayor Cheney: Has West Street been striped yet?

Mike Moser: Yes, today.

Trustee Patterson: All the way?

Mike Moser: Yes, they were working on it this afternoon. I didn't see it. Driving on the way home, I will see if they finished it. They made it all the way to Pond Hill when I was...

Deputy Mayor Cheney: Are they going to stripe the rest of it?

Mike Moser: Of ours?

Deputy Mayor Cheney: Yes.

Mike Moser: Yes, to the Village line.

Trustee Lindberg: Is that A1?

Mike Moser: Yes.

Trustee Patterson: It looks great.

Mike Moser: Thank you.

Trustee McManus: Instead of looking great, it feels great.

Deputy Mayor Cheney: That's more important.

Trustee Patterson: Definitely.
