The regular bi-monthly meeting of the Board of Trustees of the Village of Warwick was held on Monday, July 19, 2021 at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present were: Mayor, Michael J. Newhard, Trustees: Barry Cheney, Corey Bachman, and George McManus. Trustee William Lindberg was absent. **Reports**

**Trustee Cheney's Report:**

Trustee Cheney stated the Village of Warwick is moving forward with the project on River Street to install a water line that connects Howe Street to the line that comes across West Street that serves Jones Chemical and the Wastewater Treatment Plant. The DPW is about three quarters completed with the project.

The Mayor stated the DPW department is doing a great job.

DPW Supervisor, Mike Moser, stated the DPW started by Jones Chemical, went across the road, and installed two fire hydrants, three valves, numerous lengths of pipes and made it past the Getz building on River Street. The DPW Department cut across the road and will need to figure out how they will get across the bridge.

Mike Moser stated that Orange County left threaded holes on the bridge and the DPW department is in the process of purchasing hangers, pipe installation and due to the span of the bridge they are trying to get a fitting that will house the pipe. The pipe will have to be insulated because it will be exposed to the weather year around.

Mayor Newhard asked DPW Supervisor, Mike Moser, when the project will be completed. Mr. Moser stated they are waiting on material and hopes to get receive them by Thursday or early next week and should be finished right after receiving the material.

**Trustee Bachman's Report:**

Trustee Bachman stated there is a full day event with the Warwick Historical Society on Saturday, July 24, 2021. It is the George Washington Day Celebration, there will be a 5K Fun Run starting at 8:30 a.m. in Veteran's Memorial Park and free public tours on all their properties which include, Baird's Tavern, Shingle House, and the Old School Baptist Meeting House. The event will finish off with a free family fun movie at 8:15 p.m. in Lewis Park. The movie that is showing is Enchanted.

**Trustee McManus' Report:**

Trustee McManus stated schools are in session for the summer programs due to COVID. Those who were lacking some skills can continue their program and not lose time due to COVID.

Trustee McManus said the Warwick Valley Community Center Youth Leadership Academy and Coalition are working well.

Mayor Newhard stated the race on Saturday should be a challenge since we rarely have 5K races in the Village of Warwick. Lt. Rader stated the route is not terrible, it cuts over High Street, back down South Street, and works it way back to McFarland Drive and the Police Department is not anticipating any issues. The run starts at 8:30 a.m. and finishes at 10:30 a.m.
