The Regular Meeting of the Board of Trustees of the Village of Warwick was held on Monday, March 20, 2023, at 7:30 p.m. in Village Hall, 77 Main Street, Warwick, NY. Present was: Mayor, Michael J. Newhard, Trustees: Barry Cheney, Carly Foster, and William Lindberg. Also, present was Deputy Village Clerk Jennifer Mante and Village Attorney Stephen Gaba. Absent was DPW Supervisor Mike Moser. Others present: Town of Warwick Police Chief John Rader, Scot Brown, Mary Collura, and Nora Gurvich.

The Mayor called the meeting to order and led in the Pledge of Allegiance. The Deputy Village Clerk held the roll call.

#### **Discussion**

Trustee Cheney stated that it was a bit extra in cost, however, given the circumstances, it was in conformance with the Village's procurement policy where, in this case, the second lowest bid was in the best interest of the Village and can be accepted.

Trustee Lindberg asked for an updated sheet for the records. Trustee Cheney agreed to get the information from the Water Supervisor.

Trustee McKnight asked what the lead time was on the Schmidts Wholesale. Trustee Cheney replied that the hydrants were on the lot in Monticello and the order could be placed tomorrow, and the items could be delivered within two weeks.

#### Facility Use – Stanley Deming Park, Too Good to Toss

A MOTION was made by Trustee Foster, seconded by Trustee Lindberg, and carried to grant permission to Wickham Works to use the east side of Stanley-Deming Park, from 8:00 a.m. on Friday, May 19, 2023, through Monday, May 22, 2023, for the 2023 Too Good to Toss event. Permission to include use of the basketball court and lawn area around the handball court, use of restrooms and water fountains, the set-up of tents and tables for the duration of the event, use of electricity, and blocking off eighteen parking spaces near the entrance of the basketball court. Village of Warwick DPW to provide 15+ orange parking cones, reflective vests for parking volunteers, three food trucks to be parked on the grass between the creek and the handball court on the west side of the park, 10 to 12 garbage cans to be placed in the basketball court and around food trucks, and pickup of leftover items on Monday, May 22, 2023, by the Village of Warwick DPW. In addition, the use of designated parking in the grass behind the basketball courts in coordination with DPW Supervisor, Mike Moser. Completed facility use permit, proof of insurance, and security deposit have been received. Approval contingent upon providing the Village of Warwick with certificates of insurance naming the Village as an additional insured from all food truck vendors at least 30 days prior to the event and obtaining permission of the

#### Health Insurance, Dental Work/Eye Care

A **MOTION** was made by Trustee Lindberg, seconded by Trustee McKnight, and carried to amend the Employee Handbook Section 7.5 Health Insurance, Dental Work/Eye Care as follows: The Village shall reimburse all Full Time and Office Employees and Elected Officials for dental work and/or eye care for the employee and/or his/her family, upon verification that such dental work and/or eye care was/were performed. The annual reimbursement allowance listed by fiscal year are as follows:

June 1, 2022 – May 31, 2023	\$ 1,750.00
June 1, 2023 – May 31, 2024	\$ 1,800.00
June 1, 2024 – May 31, 2025	\$ 1,850.00
June 1, 2025 – May 31, 2026	\$ 1,900.00

To receive reimbursement for dental or optical services, the employee must submit a detailed voucher with receipts attached identifying the services rendered. In the event an employee leaves employment prior to the end of the Village's fiscal year, the amount of the stated coverage will be pro-rated based on the actual number of days the employee worked during that fiscal year. If such an employee receives dental or optical reimbursement that is greater than the pro-rated amount as stated above, the employee must pay back to the Village the portion that exceeds the pro-rated amount within ten (10) days after leaving his/her employment with the Village.

Trustee Cheney told Mr. Gaba to message the Treasurer first.

#### Reports

#### **Trustee Cheney's Report:**

#### **Trustee Foster's Report:**

Trustee Foster explained the concert motion was tabled because she wanted to discuss having more concerts at Stanley-Deming. Trustee Foster explained her reasoning was due to residential feedback, her own experience, more family-friendly, and how the area provided a larger space for more people to attend. Trustee Foster continued saying that the density on Railroad Green can be troublesome for those with sensory issues or anxiety and can cause people not to attend. Trustee Foster suggested a 50/50 split between Stanley-Deming and Railroad Green.

Mayor Newhard suggested having a conversation with the two concert coordinators.

Trustee Foster stated that she was clear about her feelings last year and when they came on-board had asked to be part of the decision-making process and be part of the meetings and was not.

Mayor Newhard said there weren't many meetings.

Trustee McKnight added that as Trustee Foster oversees parks she should have been front and center of that meeting, and asked what the next steps should be.

Trustee Foster suggested to sit down and talk about the locations, as the current proposed schedule had just two concerts at Stanley-Deming.

Mayor Newhard suggested a separate meeting with Trustee Foster.

#### **Trustee Lindberg's Report:**

Trustee Lindberg stated that he had been a trustee for twelve-years and seven months and how it was an honor to serve the Village of Warwick. Trustee Lindberg shared some great memories, such as the Sesquicentennial event in 2017 being one of the highlights, and one of the low points was going through Covid. Trustee Lindberg was very satisfied on how the Village handled Covid, from how public interaction was managed at Village Hall, to the outdoor restaurants on Main Street.

Trustee Lindberg was grateful for the great staff at Village Hall, calling Mayor Newhard the heart and soul of the Village. Trustee Lindberg said he had known Trustee Cheney for many years and was glad he was a Board member. Trustee Lindberg was very impressed with Trustee Foster and Trustee McKnight, emphasizing their attention to detail and enthusiasm. Trustee Lindberg acknowledged the Village Clerk, Raina Abramson, Deputy Clerk, Jennifer Mante, and Village Treasurer, Sadie Becker, as well as the Village's legal counsel, Steven Gaba.

Trustee Lindberg stated the difference in the Village of Warwick's Board was that they were not Republicans and Democrats, but people who want to do the right thing, follow the Village Code, and update the codes if necessary. Trustee Lindberg said there are arguments, but at the end of the day, the Board will come up with the right decision, which was very satisfying.

Trustee Lindberg described his excitement driving or walking down Main Street with the stores, the vibe, the people, and how incredible it all was. Trustee Lindberg stated one of the problems with the Village was not having enough parking and how it needed to be worked on, but emphasized that it was a good problem to have.

Trustee Foster stated that she had been honored to serve next to Trustee Lindberg and how wonderful it had been to work with him and learn from him. Trustee Foster said in observing Trustee Lindberg in action, noticed how much he cares about the Village and thanked him for coming back and serving the Village.

Mayor Newhard said he considered Trustee Lindberg a true friend and had been extraordinary in his role as a trustee. Mayor Newhard explained that the work was not glamorous, but behind the scenes where the public does not often see, however the fruits of Trustee Lindberg's many years

of labor was seen in terms of policies and thoughtful understanding of creating local law. Mayor Newhard stated how Trustee Lindberg had been a Godsend to the Board as an organization, to the people of the community, and he could not thank him enough.

#### **Mayor Newhard's Report:**

Mayor Newhard said the Board had submitted applications for the Community Project Funding for the New York Congressional District 18. Mayor Newhard thanked the entire Board, particularly Trustee Foster, as well as the Clerk, the Deputy Clerk, and everyone who responded to letter requests at the last minute in a 24 hour-turnaround. It was a pleasure to watch Jenn hit send for the two applications, one to potentially fund Well #3, which was a big project, and the second was to potentially fund the skatepark. Mayor Newhard said that people were very enthusiastic, and he hoped that when read, the enthusiasm would show. Mayor Newhard said he was heartened by all the work that had taken place this year in seeking funding for some of these large, very expensive projects and if we get anything, it would be great, but a lot was learned along the way, which was just as important.

Trustee McKnight said that over the past year as a Trustee he noticed the extreme amount of work that goes into applying for grants, how there was an unlikelihood of getting the funding, and how much it showed dedication and passion. Trustee McKnight said he was learning from Trustee Foster, and how amazing it would be for the Village if we do earn those grants.

Trustee Foster said that not one of them has been a single-person effort, but a full team effort.

Mayor Newhard thanked all those involved.

#### **Final Comments from the Floor**

Nora Gurvich thanked the Board for approving The Historical Society's George Washington Day 5K and Fun Run and went into detail regarding the race. Ms. Gurvich promoted The Historical Society's events that were to take place this year, such as free historic open house tours, a volunteer painting event, new exhibits, school tours, the 'Hands on History' program, and was hopeful to add some historical walking tours.
