Correspondence

 Letter from Law Office of Blustein, Shapiro, Rich & Barone, LLP dated October 26, 2020 regarding Village View Estates – Petition for Annexation and Application for Special use Permit.

Discussion

1. Handicap Parking Fines.

Trustee Lindberg stated the parking fines are currently \$100.00 and it has been previously discussed to increase this fine from \$100.00 to \$250.00. Trustee Lindberg presented some comparisons from, Greenwood Lake, Middletown, and Newburgh.

Trustee McManus stated that if somebody forgot their handicap tag, they should be able to present their tag to the judge and the penalty will be taken care of. Mayor Newhard stated that is what happens, and it is completed by the court clerk.

The Board of Trustees agreed that the fine will be increased to \$250.00.

2. Electric Vehicle Charging Station Connection Fee & Parking Fines.

Trustee Cheney stated the Police Department Parking Fines are as follows:

- Parking a vehicle other than an electric vehicle in a space designated for electric vehicle parking while charging only is a \$100 fine
- Parking a electric vehicle in a space designated for electric vehicle parking while charging only when the electric vehicle is not in the process of charging is a \$50.00 fine.
- Parking an electric vehicle in a space designated for electric vehicle parking while charging only greater than three continuous hours whether or not the electric vehicle is the process of charging is a \$50.00 fine.

Trustee Cheney stated that the Village needs to create a new category in the Village of Warwick Schedule of Fees, Electric Vehicle Charging. Much discussion ensued about what the connection fee should be. The Board of Trustees agreed the connection fee will be \$1.75/hour.

Trustee Cheney stated that the connection fee can be worked in with the handicap fees and parking regulations and will be voted on when the schedule of fees is changed.

3. Warwick Meadows, Phase IV, Proposed Residential Development – Notice to Designate a SEQRA Lead Agency.

Trustee Cheney stated the Warwick Meadows project goes back to the 1990's and the Planning Board should be the Lead Agency.

- Warwick Grove is required to pay the Village the sum of \$1,500 upon execution of the license agreement.
- Warwick Grove agrees they will indemnify and hold harmless the Village and Board of Trustees from claims.
- The agreement is from November 1, 2020 through May 1, 2021.

Trustee Cheney stated that if Warwick Grove and their contractor fails to comply with the terms and conditions of the license agreement, the Village can terminate the license upon written notice if remedies are not made.

Trustee Lindberg stated that he is against parking any equipment in the Village parking lot and he does not want to see part of the park become a storage area.

Trustee Bachman stated that he is glad there is a contract in place.

Mayor Newhard stated that he understands both sides and will agree with this for now but would prefer it not to be a continual contract going forward.

Final Comments from the Board

Trustee Cheney stated there was a sewage overflow due to fats, oils and grease that entered the sewer system from individual residences over a long period of time. Trustee Cheney would like to remind the residents that it is important that they do whatever they can to eliminate any fats, oils and grease that comes from cooking and preparing meals so they don't enter the system. Trustee Cheney suggested to let grease solidify and throw it into the garbage instead of dumping it into the drains.
