Eve Kiddie Carnival on Friday, September 30, 2022 from 6 p.m. to 9 p.m.; Saturday, October 1, 2022 from 2 p.m. to 10 p.m. and on Applefest Sunday, October 2, 2022 from 9 a.m. to 5 p.m., including pony rides by Winslow Therapeutic Riding Center, subject to the following restrictions: only ride and concession equipment can remain in the park; there will be no campers or RV's overnight except for liability purposes and to prevent damage to the equipment; one carnival employee only is permitted to stay overnight in the company trailer in Stanley Deming Park; no ride equipment may enter or be removed from the park without the Village of Warwick Department of Public Works Supervisor or his designee present; the equipment cannot enter the park prior to 9 a.m. the Wednesday prior to the event and must be removed by 3 p.m. the Tuesday following the event; if the carnival company needs to come in to set up earlier than Wednesday prior, they will need the permission of the DPW Supervisor; assembly or breakdown and removal of the equipment may occur only between the hours of 8 a.m. and 8 p.m. Completed park permit and security deposit have been received. Approval is contingent upon the Village of Warwick's insurance carrier's confirmation that proper insurance is in place.

#### **Discussion**

# **Trustee Cheney's Report:**

Trustee Cheney stated that the Village, through its consultant, Barton & Loguidice, submitted a WIIA application to New York State. Trustee Cheney explained that the application covers two projects, the main storage tank at the reservoir that needs to be replaced and the treatment system for Well #3. The total price of those projects as \$4.277 million dollars and the maximum grant award is 60%. Trustee Cheney said that the Village is very hopeful that it will be selected this time and receive the maximum. Trustee Cheney also thanked Trustee Foster and said she was very much involved in helping with the application and providing some excellent input.

#### **Trustee Foster's Report:**

Trustee Foster announced the Orange County, New York 2022 Senior Games with an opening ceremony on September 21<sup>st</sup>, 9 a.m. to 2 p.m. at the day camp area of the Thomas Bull Memorial Park, located at 211 New York 416, Montgomery, New York. There will be music, Zumba, drop-in games, a one mile walk, and lunch is also provided. There will also be nature hikes and a scavenger hunt on September 22<sup>nd</sup> from 9 a.m. to 2 p.m., with a rain date of September 27<sup>th</sup>, located at the Bellvale Bruderhof Community on 359 Gibson Hill Road, Chester, New York 10918. There will be cookies, coffee and lunch provided to hikes to choose from and a fun scavenger hunt. There will be a one time fee of \$15 and registration form to attend the Senior Games. Trustee Foster explained that she and Mayor Newhard attended the NYCOM conference last week, which was her first attendance. Trustee Foster said that she learned a lot as a new Trustee and attended sessions related to funding for local government and learned a lot about things that are coming down the pike as well as debt issuance processes and bonding, a lot about new energy opportunities, which she feels the Board will probably discuss in future board meetings, public water and sewer system operations, regulations around traffic safety, which is something Trustee Foster stated that is really important to her.

Trustee Foster also said that she learned a lot about policies and procedures that are required and recommended for managing the city and local government. Trustee Foster stated that she confirmed with Village Clerk, Raina Abramson, that the Village has the required policies and procedures in place, which is excellent and that it was good to read all of them.

Trustee Foster said that she had a really good session listening to the General Counsel, Wade Beltramo, and also got an update on what's happening in Albany. Trustee Foster said that overall, she thinks it was an extremely good use of time and energy and that she'll be happy to share her notes.

Mayor Newhard said that this particular session is focused on newly Elected and Clerk's and Treasurer's, which is wonderful in that you get to really understand the responsibilities that they have to a municipality and the enormity of their job.

Trustee Foster said that there was a lot of emphasis on how running a local government is not like running a business.

Trustee Lindberg's Report: Absent

## **Trustee McKnight's Report:**

Trustee McKnight said that the Albert Wisner Public Library is going through a strategic planning process and similar to how the Village did the Comprehensive Plan, there is an element of community outreach. Trustee McKnight explained that the library will be reaching out to their patrons, which includes anyone within the Warwick School District, over the next few weeks with surveys trying to get input. Trustee McKnight urges anyone who is listening or reading this to please respond to the survey because he feels the library is a great asset to the community and that the library relies on the community feedback.

Trustee McKnight stated that the library will be closed for Applefest, October 2, 2022, and that the following week, the highly regarded Children's Book Festival will be taking place on October 8, 2022, from 11:00 a.m. to 4:00 p.m. in Stanley Deming Park. Trustee McKnight said that every time he's been to the Book Festival, it's been a great turnout.

Trustee McKnight added that there will be a fall art show at the library from October 17 – December 30, 2022, and that right now the application process for that event is open.

Trustee McKnight stated that the Village still has an opening for an Alternate Member to the Zoning Board and clarified that the Zoning Board does not meet every month, but only when there is an item on the agenda, so although not a large time commitment, it's a very important position to what the Zoning Board does.

## **Mayor Newhard's Report:**

Mayor Newhard stated that the Village is in the midst of the NY Forward Grant application process through the New York Department of State as part of the DRI, Downtown Revitalization Initiative, that the State created about five or six years ago. Mayor Newhard said that the DRI had a grand prize of \$10 million dollars per municipality, which is not easy to get since it is very competitive and geared to and focused on larger municipalities, small cities, throughout New York State and many of them have taken advantage of it and have seen transformational projects that have made a great difference in local economy and also in terms of placemaking, truly have taken some very depressed cities and really made them shine and really changed them in terms of their direction. Mayor Newhard said that when it went into place the New York Council of Mayors started lobbying for a secondary tier because it was clear that DRI was really focused on larger municipalities. Mayor Newhard stated that finally this year, the Department of State did create that second tier which is focused on smaller, rural, historic, walkable communities which sounds like Warwick. So, for the past twenty-five days, the Village has been trying to get the grant package together, which is very intense. Mayor Newhard said that the grant applications will be reviewed regionally in the Mid-Hudson. The grant award is \$5 million dollars, and it can be divided between two municipalities at \$2.5 million dollars if the Board of Directors from the Regional Economic Development Council makes that decision.

Mayor Newhard said that he is excited and that it's been a collaborative work. Mayor Newhard explained that Trustee Foster, Trustee Cheney, and Trustee McKnight have all had some input into this process. Mayor Newhard said that he thinks that a lot of people on the surface might say that Warwick is a shining example of downtown and downtown revitalization, it's already happened here, but the reality is post-Covid things have changed dramatically with more visitors per square inch than ever before, and those visitors come with needs and also challenges. Mayor Newhard explained that that is the type of thing the Village is really understanding and looking at because it's also about moving on to the next level and to be able to embrace new businesses, new entrepreneurs and this type of grant will really give the Village the capabilities of doing that.

Trustee Foster added that some of the key themes of the grant are also serving the needs of the residents that are here now and what they need from the downtown. Trustee Foster said that residents may have seen her and the Mayor out last weekend confirming that they were on the

right track with the initiatives and the goals because they've gathered a lot of input over the course of the last eighteen months through the Comprehensive Planning process about what people want to see from the downtown. Trustee Foster said there were a lot of themes of walkability, having a welcoming place, making downtown a place that all of our needs can be met in the same location, with a greater diversity of stores and how the Village creates a framework and environment that enables that to happen such as bump outs to increase pedestrian safety, a lot of things such as that.

Trustee McKnight said that they've done a great job and that it was a lot of hard work.

Mayor Newhard said that Trustee McKnight brings in the whole idea of Climate Smart Community which is critical to in terms of whatever the Village does as we move forward and it should be colored with that because it makes such a difference in any kind of redevelopment.

Trustee Cheney said that he thinks the Village is on the right path and will keep his fingers crossed that it comes through.

Trustee Foster said if it doesn't work out this year, the Village will go after it again next year.

Mayor Newhard said that the one thing that is important and why the Village decided to move forward with this application was because after a year and a half of public outreach for the Comprehensive Master Plan the Village had a body of vision and thoughts and ideas from the people that live here and that was golden because that is really where in essence it should come from. Mayor Newhard said that that is what excited them because they've already done a lot of leg work and created a direct line of people's true understanding of what they want or what they dream that the Village could be and that was the most important part that they saw in writing the application.
