### RESOLUTION WAIVING SEWER USAGE FEES FOR HOMSTEAD VILLAGE

WHEREAS, Homestead Village is a residential condominium located in the Village of Warwick at and along Homestead Village Drive; and

WHEREAS, Homestead Village receives municipal central water and sewer service from the Village of Warwick; and

WHEREAS, under the Village's Schedule of Fees charges for sewer usage are calculated based upon metered water usage; and

WHEREAS, on each of forty-nine (49) buildings in Homestead Village there is a metered outdoor spigot on which the water output is discharged onto the ground, and is not discharged or recaptured into the Village's sanitary sewer system; and

WHEREAS, Homestead Village has requested that the Village cease counting the water used in the 49 metered outdoor spigots on its property in the calculation of Homestead Village's sewer charges because the water provided to these spigots is not discharged or recaptured into the Village's sanitary sewer system;

# NOW, THEREFORE, BE IT RESOLVED as follows:

- That the Village Board hereby grants the request of Homestead Village, and the Village shall cease including the water used in the 49 metered outdoor spigots on Homestead Village's property in the calculation of Homestead Village's sewer charges; and
- 2. That to the extent that such action may require an amendment of the Village's Schedule of Fees to be made, the said Schedule of Fees shall be deemed amended to include a provision under "Sewer Rates" waiving the fee in regard to water provided to the 49 metered outdoor spigots on the Homestead Village property; and
- 3. That the provisions of this resolution shall apply only to water and sewer bills issued to Homestead Village after June 1, 2020 and, excepting for the said bills, shall in no way affect amounts charged and owing on any other bills issued prior to the above date. The Village Water Department shall adjust the amounts due upon sewer bills issued to Homestead Village after June 1, 2020 and shall issue such rebates as the said adjustments may require.

The bridge is owned and maintained by Orange County. The bridge replacement project is tentatively scheduled for construction in 2021.
