RESTATED EASEMENT

WITNESSETH:

WHEREAS the grantor's predecessor in interest, namely Joseph Specht, previously granted unto the Village of Warwick an easement for the purpose of installing and maintaining a sewer line and appurtenances over property of Joseph Specht which easement was dated the 24th day of September, 1962 and was recorded in the Orange County Clerk's Office in Liber 1632 at page 19, and

WHEREAS, said agreement was amended by an Amended Right of Way dated
August 14, 1998 between Booker J. Smith Enterprises, Inc and the Village of Warwick
recorded September 18, 1998 in Liber 4874 Page 46 in the Office of the Orange County
Clerk, and

WHEREAS, the Grantor herein has obtained subdivision approval and a change of zoning classification and as a condition to said approval the Grantee is requiring the Grantor to confirm and restate the above sewer easement as amended, and

WHEREAS, the grantor herein wishes to confirm and restate said easement.

and other good and valuable consideration paid by the grantee, the receipt and sufficiency of which is hereby acknowledged, does hereby confirm, acknowledge and restate the existence of said 20' sewer easement as depicted on the Subdivision Plan entitled "M&L Equity Auto, LLC Subdivision and Site Plan" prepared by Friedler Engineering, PLLC dated June 26, 2023 and last revised October 1, 2024. Together with the right to enter upon and operate, maintain, repair or replace the sewer pipe line, manholes and other appurtenances on the grantor's premises. The center line of said right of way and easement is described in the aforesaid indenture from Joseph Specht to the Village of Warwick dated December 24, 1962 and recorded in Liber 1632, page 19.

All other terms, conditions, rights and duties set forth in the aforesaid easements indenture from Joseph Specht to the Village of Warwick shall remain the same.
