Final Comments from the Board

Trustee Collura announced that the Warwick Merchants Collective would be hosting the 24th Annual Ladies Night Out on August 21 from 3:00 p.m. to 8:00 p.m. The event would feature shopping, in-store activities, and specials at participating merchants and restaurants in the Village of Warwick, and the Queen would be announced.

Trustee Collura announced a new project in collaboration with recent SYLA (Student Youth Leadership Academy) graduate Eva Defreese, who is organizing a Wildcat spirit wear clothing drive. Gently used or unneeded Wildcat T-shirts and other Warwick-branded items would be collected until the beginning of September. Drop-off locations include Warwick Town Hall, Warwick Valley Community Center, Café à la Mode, and the Tourism Center at the Warwick Valley Chamber, located at 75 Main Street. Trustee Collura expressed her enthusiasm for the project, noting Eva's efforts in organizing it and the positive feedback received so far.

Mayor Newhard suggested reaching out to the school district regarding the Wildcat spirit wear clothing drive.

Trustee Collura stated that she had emailed Dr. Leach and was waiting for a response, and she would also post the information on the Village's Facebook page. She noted that the number of

drop-off locations continued to grow due to generous community support, with a new box planned for the Little League.

Trustee Cheney pointed out that Little League activities would largely pause until after September 1, but fall ball would soon begin, bringing more activity. He suggested contacting youth football, which had already started practicing on August 1, as it could reach families with children who had outgrown their spirit wear.

Trustee Collura added that she was meeting with Eva the following day and that there had been discussion about making the drive a year-round initiative.

Trustee Collura shared the backstory of the Wildcat spirit wear clothing drive, explaining that the idea arose during a lunchtime conversation with young people about bullying, particularly bullying related to clothing. She noted that while the school district holds spirit days, Wildcat Fridays, and other school pride events, some students do not have Wildcat T-shirts for various reasons. She felt the initiative would help bridge that gap and benefit many students. In discussing the project with others, she found it often sparked memories of their own school experiences, such as not having certain clothing items. She shared her own experience of wearing hand-me-downs from a decade earlier, noting with humor that those vintage items would now be highly valued.

Mayor Newhard asked how the collected Wildcat spirit wear items would be distributed, noting that while the pickup process was clear, he wanted to know the plan for distribution.

Trustee Collura responded that the distribution plan was still being developed. She was attempting to contact Four Seasons Kids, which works with Backpack Snack Attack to provide back-to-school items for students. If that option did not work out, she suggested utilizing one of Warwick's three thrift shops by setting up a table during their open hours to create a small "shop" for pickup. Alternatively, they could set up in another location and advertise the pickup site. She noted that she had a meeting scheduled with Eva the following day to finalize those details.

Trustee Cheney reminded residents that road construction work in the area was ongoing and would continue for some time. He asked for the public's patience and urged everyone to be mindful of lane closures, street closures, and detours. He emphasized the importance of driving carefully in work zones so that construction crews could feel safe while doing their jobs.

Mayor Newhard noted that the Ball Road cover project had been delayed due to various issues encountered at the work site, but progress was being made. He anticipated that the project would likely be completed within the next two weeks.

Trustee Collura asked if there was an expected start date for work on Main Street.

Trustee Cheney explained that drainage improvements at the West Street intersection were supposed to be completed within a one-to-two-month timeframe, with the actual work estimated to take about a week, but the project had not yet started.

Trustee Collura noted her concern about the timing, especially with increased traffic during the fall season, especially during Applefest.

Mayor Newhard stated that the roundabout project was beginning but would not affect traffic this year, and the culvert work on Route 94 near ShopRite was nearly complete.

Trustee Cheney highlighted the safety benefits of roundabouts, including reduced speeds and fewer severe accidents compared to traditional intersections.

Trustee Collura shared that she had initially been apprehensive to roundabouts but changed her view after visiting Ireland, where traffic flowed more smoothly, and collisions were less severe. She also observed that roundabouts there often featured attractive landscaping or art installations and suggested incorporating similar enhancements locally.

Trustee Cheney noted that such decisions would be up to the state, while Mayor Newhard added that there were limitations due to sight distance and usability.

Trustee Collura expressed concern about the space becoming unsightly if left unattended, and Mayor Newhard said that Supervisor Jesse Dwyer was aware of the concern and it was being addressed.
