#### SHORT TERM RENTAL PROPERTIES - HOW TO APPLY FOR A STR PERMIT WHAT IS A SHORT-TERM RENTAL (STR) PROPERTY?

The Village of Warwick's Short-Term Rental (STR) Code, specifically § 115-2, a "Short-Term Rental Property" is defined as any residence in which overnight accommodations are offered in exchange for a fee or compensation, whether monetary or otherwise, for a period of less than thirty (30) days. The code explicitly states that month-to-month tenancies are not considered short-term rental properties.

- A Short-Term Rental (STR) Permit will be issued upon submission of a completed application, payment of the applicable fee, and successful final inspection by the Building Inspector. In accordance with § 115-6 (Duration and Terms of Short-Term Rental Permits), all STR permits are valid for one year from the date of issuance, unless revoked prior to expiration."
