2. <u>RESOLUTION</u> <u>VILLAGE OF WARWICK BOARD OF TRUSTEES</u> LOAN TO WELL #3 CAPITAL PROJECT FUND

WHEREAS: The Village is installing Well #3 and related infrastructure to improve its water supply system, which capital project is paid in part by a grant awarded by EPA Clean Water Drinking Grant, and expensed from the Well #3 Capital Project Fund (H fund). The current balance in the H fund is not sufficient to pay current project expenses, although the Board of Trustees anticipates receiving grant funds prior to the end of the 2025 calendar year. Accordingly, the Board

intends to authorize a loan from the Water (F fund) to the H fund, which loan will be paid back to the Water (F fund) upon receipt of grant funding.

THEREFORE, IT IS RESOLVED that the Board of Trustees authorizes a loan in the amount of \$717,629.39 from the Water (F fund) to the Well #3 Capital Project Fund (H fund), which loan shall be paid back to the F fund upon receipt of grant funding.
