## SLOW DOWN WARWICK INITIATIVE

The Village speed limit is 25 miles per hour. Speed radar signs have been placed around the Village for the past year and the data collected will be available for public viewing in the next few months.

Speeding has been a growing concern for residents and everyone that uses our roadways. The Village has implemented several traffic calming practices and continues to address the issue.

Please do your part in keeping all our roadways safe for everyone who uses it.

## TREE CITY, USA



**TREE CITY USA®**

The Village of Warwick is celebrating its 40th year designated as a Tree-City community in New York State, making it the longest consecutive recipient of the growth award in New York State.

The Village of Warwick has received national recognition as a Tree City USA each year since 1983 from The Arbor Day Foundation, a national nonprofit organization dedicated to planting trees and other conservation efforts.

### CUTTING DOWN TREES

**When cutting down a tree, certain restrictions apply:**

*No live tree wider than 4 inches in diameter (measured at the height of 6 feet) shall be cut unless...*

- It causes hardship or endangers the public or an adjoining property owner
- It is in an area to be occupied by a building, driveway, or recreation area (determined by the building inspector)
- It is in an area deemed hostile to tree survival
- It would help encourage the growth of prime specimen trees (determined by the building inspector)

The Village of Warwick will be celebrating Arbor Day this year by planting a tree in the Roger Metzger Arboretum in Stanley-Deming Park. The annual celebration will be held on Friday, April 26 beginning at 9 a.m.

Park Avenue Elementary School students are invited to join in our celebration. In addition, Pat Reinhardt and the Warwick Valley Gardeners are invited as guests and often bring poems and music to share with all those present. It is the goal to instill in the children the love of trees as well as educate them on the value trees bring to our daily lives so that they too can help protect our environment.

## VILLAGE OF WARWICK SHADE TREE COMMISSION

The Shade Tree Commission is an appointed body made up of three members, including one chairperson. The current Shade Tree Commissioner is Lynn Cheney and member Sherwood Stevens.

The role of the Commission is to establish and enforce street tree planting and removal regulations, and to provide plans for the encouragement of tree plantings. The Commission, along with the Department of Public Works, is also responsible for planting, feeding, and maintaining street trees and trees in the Village's numerous parks.

The Village of Warwick Shade Tree Commission meets monthly to review the status of trees in the Village.

# INFRASTRUCTURE PROJECT UPDATE

## Wastewater Treatment Plant Upgrade

The upgrade will include increasing the plant capacity to 1.25 MGD and employing a new technology. The design plans and specifications are complete and are currently being reviewed by the NYS Department of Environmental Conservation. The Village expects to request and receive bids late Spring and start construction in the Summer. Construction is expected to take 18 months. The project is being funded in part through a \$3,000,000 grant from the NYS Environmental Facilities Corporation.

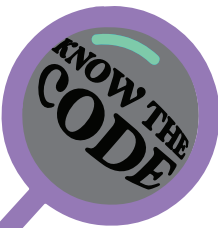
## Maple Ave Pump Station Relocation

The project will relocate the current water pump station from the island at the intersection of Maple and Colonial to Grand St. across from Fairview Ave. A new above ground pump station will be constructed at that location. The design is complete and is currently being reviewed by the State and

County Health Departments. The project has received partial funding through a \$250,000 grant from State Senator James Skoufis. Bids should be received in July with construction to start in September and completed in 12 months.

## Well #3 Treatment Plant

Construction of a treatment plant for Well #3 will allow the Village to incorporate that source into the system to increase the resilience of our Village water supply. The design is complete and has received approval of the Health Department. The project will receive funding from a \$964,000 federal grant through the Office of Congressman Pat Ryan. The Village will use \$694,868 that it received from the American Rescue Plan Act of 2021 which should cover the remainder of the cost. The Village should be receiving bids by early Summer with construction starting a few months later and lasting about 14 months.

## THE VILLAGE CODE REGARDING DOGS: LEASHING, BARKING, PICKING UP AFTER; IMPOUNDMENT AND PENALTIES FOR OFFENCES

### § 36-1 Running at large prohibited; leashing required.

No person owning or having custody or control of a dog, whether or not tagged or licensed, shall permit such dog to be at large in the Village of Warwick elsewhere than on the premises of the owner or person

having such custody and control, unless restrained by a chain or leash not exceeding six feet in length.

### § 36-2 Disturbance of peace prohibited.

Any person owning, harboring or having the care, custody or charge of any dog, when such dog is housed or confined, shall so house and confine such dog in a place so constructed as to prevent the disturbance of persons residing in the neighborhood by habitual or continued barking of such dog.

### § 36-3 Seizure and impoundment.

Any dog running at large, whether or not tagged or licensed, contrary to the provisions of this Article within the limits of the Village of Warwick shall be subject to seizure and impounding by any police officer or by any other person or agency designated by the Village officials or authorized by law to seize and impound animals pursuant to Article 7, Section 120, of the Agriculture and Markets Law of the State of New York, as amended.

### § 36-4 Notice of seizure and impoundment.

After such seizure and impounding, the owner of such dog, if known, shall be notified in accordance with Article 7, Section 114-a, of the Agriculture and Markets Law of the State of New York, as amended, if unlicensed and untagged, and if unleashed but bearing a license tag the owner shall be notified in accordance with Article 7, Section 114-a, of the Agriculture and Markets Law of the State of New York, as amended.

### § 36-5 Forfeiture of title to unredeemed dogs.

If said dog is not redeemed, the owner shall forfeit all title to the dog as provided in the aforesaid sections of Article 7 of the Agriculture and Markets Law of the State of New York, as amended.

### § 36-6 Nuisances; removal of feces. [1]

[Added 5-14-1990 by L.L. No. 5-1990]

A. It shall be unlawful for any person or persons owning, harboring or having the care, custody or control of any dog to permit such dog to soil, defile, defecate on or commit any nuisance upon any common thoroughfare, sidewalk, passage-way, public street, play area, park or any place where people congregate or walk or upon any public property whatsoever or upon any private property without the permission of the owner of said property. The restriction in this section shall not apply to that portion of a street lying between the curblines, which portion may be used to curb such dog, provided that such person shall immediately remove all feces deposited by such dog as follows:

(1) Feces shall be picked up with a scoop, shovel, broom, tong or other similar implement and be deposited directly into an airtight container, plastic or otherwise, and then subsequently deposited in a container used for the disposal of refuse or by any other method approved by the Board of Health.

(2) In no event shall any feces be deposited in sewers or drains, whether storm or sanitary.

B. This section may be enforced by the Dog Warden, Health Department, Police Department or any private citizen by the filing of a complaint in the Village Justice Court.

C. Guide dogs excepted. The provisions of this section shall not apply to blind persons who may use dogs as guides.

[1] Editor's Note: Former § 36-6, Penalties for offenses, was amended and renumbered as § 36-6.1 5-14-1990 by L.L. No. 5-1990.

### § 36-6.1 Penalties for offenses.

[Added 5-14-1990 by L.L. No. 5-1990]

Any person violating this Article shall be subject to a fine not exceeding \$250 or imprisonment for not more than 15 days, or both.

## FROM THE BUILDING DEPARTMENT

**PLEASE NOTE:** The building of any shed, fences, pergolas, generators and car chargers require a permit. Discovery of an unpermitted item will double the standard fee of \$150.

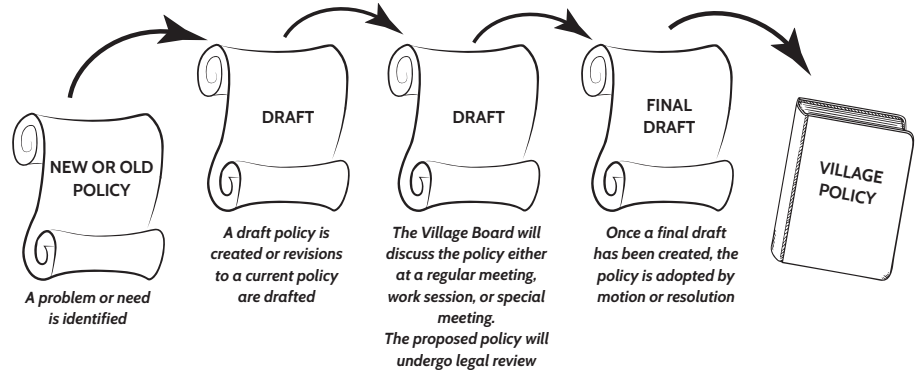

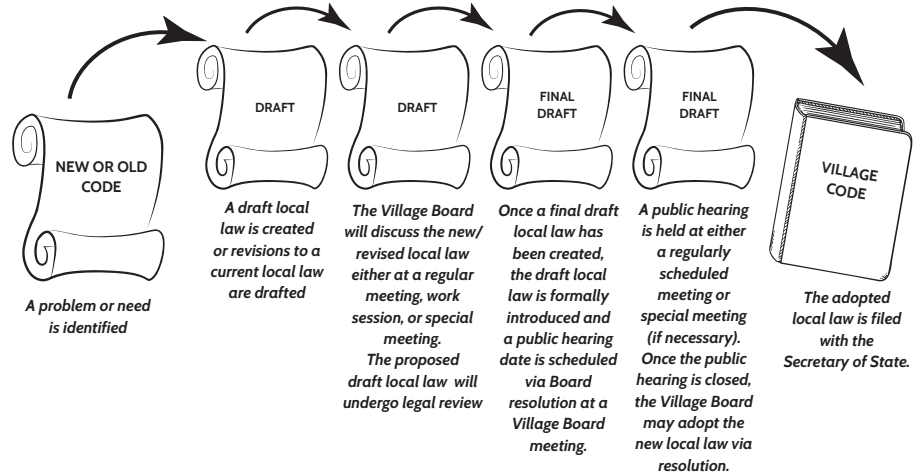

## MEET THE CANDIDATES

### MARY COLLURA

#### INCUMBENT



It has been an honor and a privilege to serve as Village Trustee since April 3, 2023. The year has been filled with lots of projects and initiatives and I look forward to continuing my work in the next term.

As I moved into my elected position, I have felt so much support from the community, the Mayor, fellow board members, staff and village departments. New York Conference of Mayors (NYCOM) has been a great resource offering training and informational classes. These trainings make me more effective at guiding decisions made at Village Hall. I have completed fifty hours of training in ten months, mostly through a week-long training session with NYCOM. This was a valuable experience to meet other elected officials from cities and villages throughout New York State. Sharing experiences and challenges has given me a deep insight into my role.

I have also completed training as a Youth Mental Health First Responder. As liaison to Public Health, my focus has been on Mental Health which I feel, in a post-Covid world, is necessary.

As liaison to Warwick Valley Prevention Coalition, I have completed a NARCAN training and attended webinars regarding the

opioid crisis and other substance abuse concerns.

As liaison to Public Interface and Outreach, I have been working with the Mayor, fellow board members, staff and Village Departments to produce a quarterly newsletter. This has been on the "wish list" for some time, and with my skill-set in graphic design and layout, I am happy to see it come to fruition. The newsletter gives the public insight on what the village board is up to. This year, the Village has been making great strides in projects and funding and it has been greatly rewarding to have a platform to share this information with the public.

As liaison to Senior Citizens, I have had the opportunity to visit the Warwick Seniors at their weekly meetings and was a volunteer at the Annual Town of Warwick Senior Picnic.

The projects I will continue my work on include: the quarterly Village Newsletter; Slow Down Warwick Campaign; Inclusion Task Force; and the creation of informational print collateral for Village departments and boards.

I have enjoyed the work, the process to achieve goals. What I have enjoyed the most is attending countless events, meeting and talking to people in our community. This is what really inspires and fuels me to continue my work serving the Village of Warwick.

### BARRY CHENEY

#### INCUMBENT



I am currently serving in my 16th year as a Village Trustee, and it has been a privilege. During that time, I have used my background as a Civil/Environmental Engineer to lead the many infrastructure projects that have been undertaken. The Village has made great strides in updating and improving its infrastructure but there is still more work to be done. Ongoing projects include

expanding and updating the wastewater treatment plant and relocating the Maple Avenue Pump Station. We will also be constructing a treatment system for Well #3, which will provide capacity redundancy, making the Village more resilient to drought and allow for scheduled and emergency repairs to other water treatment facilities.

As part of a Village Board I have worked to successfully write and direct successful grants for these necessary projects. The Village received a \$3,000,000 grant for the wastewater treatment plant project, a \$950,000 grant for the Well #3 treatment plant. We obtained \$288,000 to purchase or obtain conservation easements for properties in the reservoir watershed and received a grant of \$575,000 to perform a mandated inventory and assessment of lead service lines

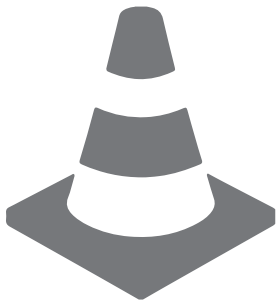
with the future goal being to replace the lines with lead free connections and piping. All this takes some of the financial burden away from the Village taxpayer and allows us to make greater progress in our efforts to maintain and improve our infrastructure.

In addition to these major projects, there are technical reports and interactions with regulatory agencies, which I have taken responsibility for, and thus, reducing our dependency and cost for consultants to perform this work.

I have managed the conversion project of our streetlights to LED lighting, which is expected to not only save energy but save the Village over \$1,500,000 over the next 20 years. This project is in its final stages and is expected to be completed this summer after which the Village will have direct responsibility for the system.

During my 45 years as a Village resident I served on the Village Planning Board for 23 years including six as Chairman prior to being elected as a Trustee. I am also a Director of Warwick Little League, serve on the Board of the Warwick Prevention Coalition, am a member of the Community Garden and Orchard and am active in the Warwick United Methodist Church. I also serve on the County Legislature.

### BRUSH PILE

The Village of Warwick will again have the Brush Disposal Program. A Valid Picture ID showing Village Residency will be required at the site.

Only Village of Warwick Residents will be allowed to dispose brush at the disposal site. The disposal area is located at the Village of Warwick Dept of Public Works site in Veterans Memorial Park. No commercial operators will be permitted.

Brush cannot exceed 6" in diameter. Bagged leaves will be accepted. (paper only). No grass clippings will be allowed.

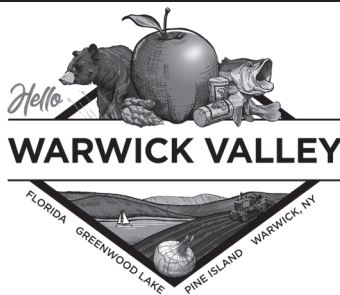
